


# Equality Objectives Statement

We believe that our pupils should be exposed to ideas and concepts that may challenge their understanding to help ensure that pupils learn to become more accepting and inclusive of others. Challenging and controversial concepts will be delivered in a way that prevents discrimination, and instead promotes inclusive attitudes.

## **Dealing with prejudice**

**Central Community and Ashgate Nurseries** does not tolerate any form of prejudice-related incident. Whether direct or indirect, we treat discrimination against all members of our school with the utmost severity. When an incident is reported, through a thorough reporting procedure, our school is devoted to ensuring appropriate action is taken and a resolution is put into place which is both fair and firm.

At **Central Community and Ashgate Nurseries**, our pupils are taught to be:

- Eager to reach their full potential.

- Incorporating lessons about diversity into the curriculum.
